Night works, temporary road and footpath changes

Dear neighbour

The NSW Government is delivering a new Sydney Fish Market which will retain its authentic experience and strengthen its position as one of Australia's leading tourist destinations.

Upcoming work – Temporary substation kiosk installation works

From **Tuesday 23 November 2021**, we will be undertaking work to install a temporary substation kiosk and associated cabling works that will provide power for the construction site. Works have been scheduled as **night works** due to the highly disruptive nature of the works to traffic and pedestrians in consideration for public safety.

It is noted that these dates are subject to change pending inclement weather, and potential impacts of the NSW Government lockdown restrictions. The locations for the works are shown in Figure 1.

Equipment used will include, but not limited to, hand-held and electric tools, light and heavy vehicles and portable lights to provide visibility for workers at night.

How this affects you

Out of hours work will be carried out between **8:00pm – 5:00am Tuesday to Thursday** for 4 weeks then **8:00pm – 5:00am Monday to Wednesday** for 1 week. Works have been limited to 3 nights per week to provide respite for residents and affected stakeholders. Noisy works such as saw cutting will be undertaken earlier in the shift.

While some work will be noisy, the project team will take every step possible to minimise noise impacts. A range of mitigation measures will be in place to meet the project's approval conditions and reduce noise, including using machinery with engine exhaust mufflers and installing noise absorbing blankets around the work zone.

The work will involve temporary footpath and traffic lane closures along Bridge Road, with alternative pedestrian routes to be provided.

- Guiding vehicles and cyclists along the work zone with traffic control and signage. There will be closure of up to two lanes depending on the stage of works.
- Providing alternative pedestrian routes with traffic control guidance. Footpaths will be maintained during works where possible, while temporary pedestrian crossings will be set up and managed by traffic controllers to safely guide pedestrians across the road.


The work zones will be removed at the end of each shift, and travel along the road and footpath will continue as normal outside the scheduled hours.
